

EMERGENCY MEDICAL SERVICES MILLAGE REQUEST
(This proposal, if approved by the voters, permits the Township to levy 2 mills to provide emergency medical services within the Township for 4 years beginning in 2012)
Shall the tax limitation imposed under Article IX, Section 6 of the Michigan Constitution on all taxable real and tangible personal property in Kinross Charter Township, Chippewa County Michigan be increased in an amount not to exceed 2 mills (\$2.00 per \$1,000 of taxable value) for a period of four years, being 2012, 2013, 2014, and 2015 inclusive, for the purpose of operating, equipping, purchasing, and making capital expenditures for Kinross Charter Township Emergency Medical Services; and shall the Township levy such millage for said purpose, thereby raising an estimated \$87,975.36 in the first year?
